3. About the introduction of the delegation-based executive officer with title structure

(1) Purpose of the introduction

We have had an executive officer structure before, however, for the purpose of shifting to a system that makes the separation of the "management and supervisory function" and the "business execution function", we introduce a delegation-based executive officer with title structure.

(2) Overview

- The structure consists of executive officers with title (President and Managing Executive Officer etc.) and Executive Officers.
- Executive officers with title are Delegated type and executive officers are employment type. *We abolish the senior executive officers.
- Executive officers with title may serve as delegated directors.
- The tenure of executive officers with title shall for one year and the appointment and dismissal of executive officers with title shall be determined by the Bord of Directors' meeting upon having received a report from the Nomination and Compensation Committee.
